- A lawyer should be honest and fair even if judgment is against their client. This involves dealing with the facts and the law honestly.
- Competence and diligence

- Patience & Listening
- Avoidance of interruptions
- Fairness to both parties
- Avoid un necessary adjournments
- Quick Disposal of cases
- Grounded in the Law
- Good appearance and conduct.

Bearing in mind the above duties, it is paramount to note that a good relationship between the two promotes independence of the judiciary and leads to effective administration of justice due a symbiotic relationship. In addition, the bench needs to practice and adhere to the core values of judicial conduct as contained in the judicial code of conduct viz-

- Independence

- Propriety
- Equality
- Accountability
- Transparency
